
2. Accordingly, this Ministry has decided to invite a fresh Sealed quotations for submitting the rates to dispose of the above mentioned vehicle on the terms and conditions mentioned below. In case you are interested in purchasing the above mentioned vehicle, you may submit your highest quotation in the enclosed proforma. The quotations addressed to Under Secretary (Protocol), Ministry of Micro, Small & Medium Enterprises, Room No. 49 Udyog Bhawan, New Delhi in a sealed cover should reach this Ministry latest by **3.00 PM on 30th August, 2013**. The cover should be prominently super- scribed with the words "Quotations FOR PURCHASE OF CONDEMED VEHICLE". The vehicle will be available for inspection on any working day between 10.30 AM to 11.30 AM upto 27th August, 2013.

3. **The quotations so received will be opened on the same day i.e 30th August, 2013 at 3.30 PM in Room No.429-D, Udyog Bhawan, New Delhi.** The bidders or their representative may be present, if they so desire, at the time of opening of quotations.

The sale will be governed by the following conditions:

- (i) The bidder is required to pay **Earnest Money of Rs.5000/-** along with the quotation.
- (ii) Earnest Money is payable only by way of **Demand Draft drawn in favour of "DDO, Ministry of Micro, Small & Medium Enterprises, New Delhi". (payment by cheque or cash shall not be accepted)**
- (iii) Quotations received without Demand Draft towards Earnest Money will not be considered.

- (iv) The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favour of DDO, Ministry of Micro, Small & Medium Enterprises, New Delhi within three working days from the date of acceptance of the bid.
- (v) The Earnest Money of the successful bidder will be released only after he deposits the sale proceeds. Earnest Money will not be adjusted as sale proceeds and be forfeited if he fails to honour the bid.
- (vi) The successful bidder will be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. The office will not be responsible for any lapse on his part in this regard.
- (vii) The delivery of the sold vehicle will be made only after all the transfer documents are completed.
- (viii) The government reserves the right to accept or reject any/all of the quotations without assigning any reason thereof.
