- The earnest money of Rs.10,000/-(Rupees Ten Thousand only) to be deposited through a Demand Draft on any scheduled bank in Delhi/New Delhi drawn in favour of Pay & Accounts Officer, Ministry of Micro, Small & Medium Enterprises, New Delhi must accompany the quotation letter. Quotation received without earnest money will not be considered. Earnest money received from the Tenderer will be returned to unsuccessful bidders without interest immediately after the process of selecting the awardee is over. The other requisite document mentioned above shall be accompanied with the quotation letters.
- 5. Quotation received after due date and time will not be accepted. The undersigned reserves the right to reduce or increase the number of items offered. The undersigned also reserve the right to reject any quotation without assigning any reason. - 8. The items shall be sold to the highest price of bidder. No items once disposed to the successful bidder shall be taken back by Ministry of MSME.
- 9. The successful bidder has to make full balance payment in the form of Cash/Demand Draft/Pay Order of any Nationalized /Scheduled Bank drawn in favour of "Pay & Accounts Officer, Ministry of MSME payable at New Delhi within three (3) days after confirmation, failing which the offer may be cancelled and EMD stands forfeited.
